### Follow-up solution for vacuum specialist Meßner

A follow-up solution has been achieved under the debtor-in-possession proceedings for Meßner GmbH & Co. KG based in the East Westphalia-Lippe region. Newly founded Meßner Produktions GmbH & Co. KG has acquired the business operations and the some 40 employees effective 1 March 2024. The site has also been saved. The restructuring team has therefore found the best possible solution for the long-standing company. The creditors' assembly unanimously approved the sale in the past week.

Since early October 2023, Meßner had been involved in debtor-in-possession restructuring proceedings, where management remains in charge and guides the company in question through the proceedings itself. Attorney Mr Philip Konen and business management expert Mr Ludwig Stern from PLUTA Rechtsanwalts GmbH had been acting as general agents and were responsible for implementing the restructuring measures. They were assisted in this by attorney Ms Kristina Breuer. Attorney Mr Martin Schmidt from law firm AndresPartner was appointed insolvency monitor and was overseeing the proceedings in the interests of creditors.
